Thank you for your application for an Emerging Minds Network research grant in response to the first funding call which closed in June 2021.

On behalf of the Economic and Social Science Research Council (“ESRC”) funded Emerging Minds Network (‘Emerging Minds’) based at the University of Oxford (‘Oxford’) under the cross-disciplinary Mental Health Network plus Initiative, supported by UK Research & Innovation (“UKRI”) we are pleased to offer XXXX (“the Lead Organisation”) a research grant of XXXX (“Grant”) for carrying out the project entitled XXXX. The Project:

1. The Lead Organisation will use its reasonable endeavours to ensure that the Project is undertaken as detailed in the Application with a start date of XXXX a duration of 12 months and a completion date of no later than September 2022.
2. The Lead Applicant or other delegated representative of the Lead Organisation will participate in meetings arranged by the Emerging Minds Network. This will include participating in mid-term and final review workshops.
3. The Lead Applicant or other delegated representative of the Lead Organisation will work with the Emerging Minds Network Manager to share progress and final findings, and outputs with the Emerging Minds Network and key stakeholders.



4. The Lead Organisation will provide financial and activity updates mid-way through the Project and at the end of the Project, reporting on actual expenditure in relation to the budget awarded as detailed in the Annex B. (i.e.: fEC and award for each eligible budget heading).
5. Within one month of the end of the Project, the Lead Applicant or other delegated representative of the Lead Organisation will provide a short report for the Emerging Minds Network describing what has been achieved and how findings and outputs have been shared in addition to Research Fish reporting requirements ("Final Project Report").
6. The Lead Applicant or other delegated representative of the Lead Organisation will provide the Emerging Minds Network Manager with informal progress updates on request, as well as notifications of any anticipated delays or problems with the Project's progress.
7. The Lead Organisation will ensure that all expenditure is subject to robust controls to ensure value for money and propriety; all costs should be fully vouched for and maintained for the ESRC's inspection and checks.
8. The Lead Organisation will ensure that all publications and presentations relating to the Project acknowledge the financial support provided by the Emerging Minds Network and the UKRI grant (ES/S004726/2).
9. Any intellectual property, know-how and results created in the course of the Project shall be owned by the Lead Organisation (or as otherwise agreed with its co-applicants as applicable).
10. The Lead Organisation grants Oxford and a non-exclusive, indefinite, fully-paid up, royalty free licence, to publish summaries and research outputs (such as published papers) of the Project on the Emerging Minds Network (e.g. website and newsletters) and in reports to the ESRC . The Lead Organisation will ensure that it obtains the necessary rights to enable it to grant this licence. The Lead Applicant (and co-applicants as applicable) will be acknowledged as author (s) in any publications related to the Emerging Minds Network.
11. The Lead Organisation will ensure that all necessary permissions and consents are obtained and comply with the ESRC's Framework for Research Ethics - <http://www.esrc.ac.uk/about-esrc/information/research-ethics.aspx>
12. The Lead Organization is required to make any research data created or repurposed for the Project, available for reuse and archiving via the ESRC's Data Store - <http://www.data-archive.ac.uk>
13. The Lead Organisation shall ensure compliance with the General Data Protection Regulation 2016/679, the Data Protection Act 2018 and any guidance or codes of practice issues by the Information Commissioner's Office (all as amended, re-enacted or replaced from time to time) regarding the processing of personal data in connection with the Project.

The Funding:

14. The Grant payment is inclusive of any applicable VAT and is for the costs set out in Annex B.
15. The Lead Organisation will submit one invoice to Oxford for 50% of the full amount of Grant payment once the Award Letter has been signed; and an invoice for the remaining 50% of the



Grant payment at the end of the Project, upon acceptance of the Final Project Report. Both invoices will quote reference XXXX and the final invoice should include a separate itemised statement of all actual expenditure incurred against the Project expenses headings detailed in the budget (Annex B).
