- Projects of up to 6 months duration
- Beginning by April 2022 and completed by October 2022
- Total funding available £140,000
  Either 1 project of £140,000 or 2 x projects £70,000
- Strongly encourage research collaborations across disciplines and sectors
- Project lead or one of co-leads must be based at the UK Higher Education Institution

- Feedback on expressions of interest by 8 November 2021
- Deadline for applications 9am 16 December 2021
- Zoom interviews for shortlisted applicants February 2022

#### Funding Call - Reviewer Advice

For our first Emerging Minds funding call, we have brought together a team of young people who are experts by experience, as well as parents and carers of children & young people who have experienced mental health problems.

Our Emerging Minds Reviewers and members of Advisory group were joined by members of the institute for Mental Health's Youth Advisory Group at several of our proposal development workshops.



We asked our Reviewers to look at the three selection criteria which we will be using during the funding call:

- · Potential for Impact
- · Research excellence, planning and management
- Collaboration and Involvement

They shared their feedback with us around what they will be looking for in applications, including common pitfalls to avoid and their recommendations for best practice.

## Impact

- To what extent is this project likely to make a significant contribution to the priorities identified by stakeholders as well as addressing our Big Question research challenge.
- To what extent will the outputs of this project be useful for and shared with those that can best use them?
- What is the potential for the research to be sustained and/ or developed?



# Collaboration & Involvement

- Does the project include non- HEI partners in substantive and meaningful ways?
- To what extent are young people, family members and other stakeholders meaningfully involved in each aspect of the project,
- Does the project offer opportunities for Early Career Researchers?
- To what extent does this project make the most of opportunities for collaboration across disciplines to maximise potential impact?



## Research excellence & planning

- Is there a clear rationale for this study, justified with reference to the existing research literature?
- Will the proposed methods achieve the research aims?
- To what extent can the proposed project be realistically implemented in the proposed timeframe?



## Emerging Research excellence & planning

- Does the project team have the relevant abilities, commitment and support to implement the project?
- Do the funds requested represent value for money in relation to the planned work and the outcomes likely to be achievable?
- Will risks be mitigated and managed appropriately (e.g. safeguarding, ethical, governance, information security and intellectual property)?
- Is there evidence of a commitment to reproducible research practices?



#### Funding call - finances

- Emerging Minds can cover 80% of full economic costs of project (following UKRI guidelines)
- Non- academic partners (such as charities) can receive up to 30% of total applied for.

- Non-academic partners can claim 100% of their costs
- Discuss our standard terms & conditions with your contracts/ business development team



## Funding call - finances

#### For example:

 For a university to receive a grant of £35,000, would need to outline project costs in your budget of £43,750 (Full Economic costs)

 Administrative costs (including estates and indirect costs) should be carefully considered and not constitute more than 20% of total application costs
